Defendant Bond Agreement

Bail jumping and failure to appear

Failure to appear in court may result in Bail jumping charges being filed against you. Bail jumping is a 3rd degree felony. A 3rd degree felony is punishable by imprisonment for any term of not more than 10 years or less than 2 years, and a fine not to exceed \$10,000.

Bond conditions

1. Not to depart the court's jurisdiction without prior written permission from 615 Nashville Bail Bonds.
2. To immediately notify 615 Nashville bail bonds of any changes of employment, address, or telephone number.

3. To make an effort to retain an attorney and maintain employment.
4. I agree to check in each month by phone at [\(615\)-629-7216](tel:615-629-7216) during normal business hours of 8:00 a.m. to 8:00 p.m. until all bonds are exonerated.
5. I understand that it is my **sole** responsibility to know my own court dates and to appear as directed by the court.
6. I understand that if I am incarcerated on any other charge(s), it is a violation of this Bond agreement.
7. The following are special conditions you must abide by: _____

8. _____ this is a domestic violence offense. You are ordered to have no contact with the victim. Violation of this order is a criminal offense under G. L. 1956 12-29-4 and will subject violators to arrest.


Acknowledgment of defendant


